OUR LEGACY

In 1961, legendary New Zealand play activist, Beverley Morris, volunteered at an Adventure Playground in South London where she met IPA World pioneer, Lady Allen of Hurtwood. Inspired by seeing the power of play for children's development, Beverley returned to Aotearoa to become a forerunner in the national play movement, establishing adventure playgrounds, developing the Playcentre education curriculum, and lobbying the government to promote the rights of all children to play, their way. Her influence to value play on the child's terms has shaped the structure of New Zealand society and revolutionised early childhood education in Aotearoa. We carry this legacy forward for all tamariki and rangatahi in Aotearoa and throughout the world.

ARTICLE 31 OF THE UNCROC

"That every child has the right to rest and leisure, to engage in play and recreational activities appropriate to the age of the child and to participate freely in cultural life and the arts.

That member governments shall respect and promote the right of the child to participate fully in cultural and artistic life and shall encourage the provision of appropriate and equal opportunities for cultural, artistic, recreational and leisure activity."
